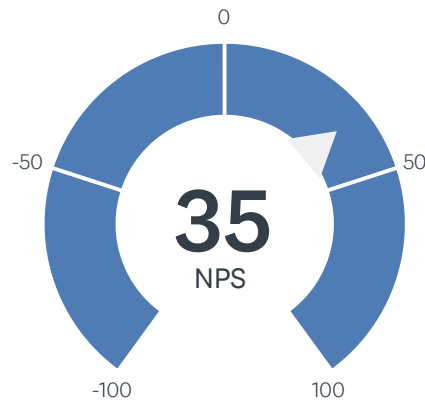


Q1 How likely is it that you would recommend attending the Spring Plenary - Hybrid Event to your colleagues?

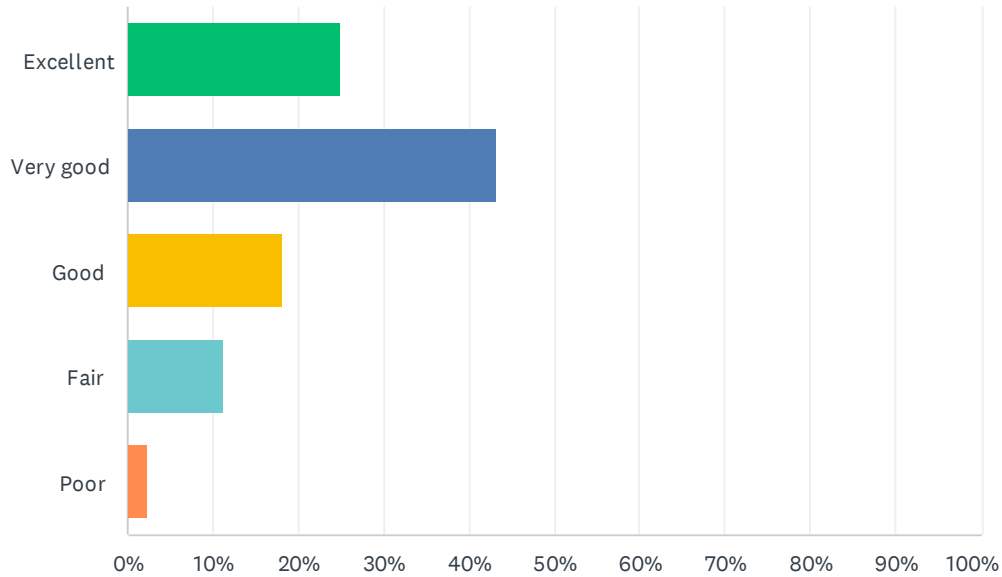

Q2 Overall, how would you rate the Spring Plenary Session - Hybrid Event?

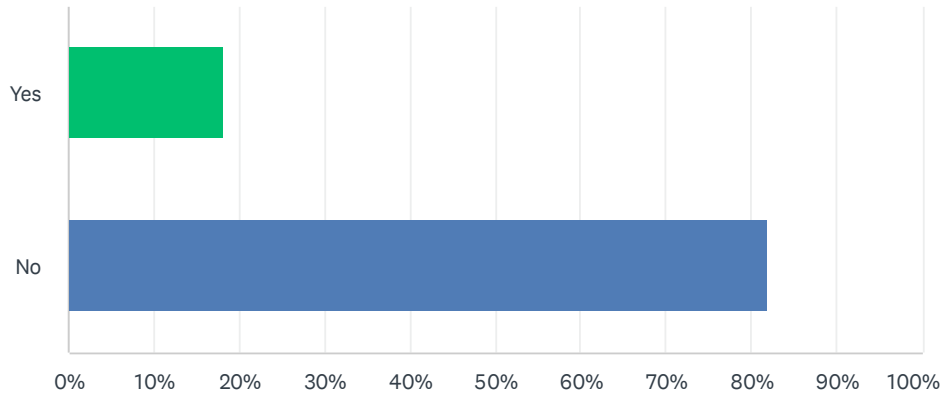

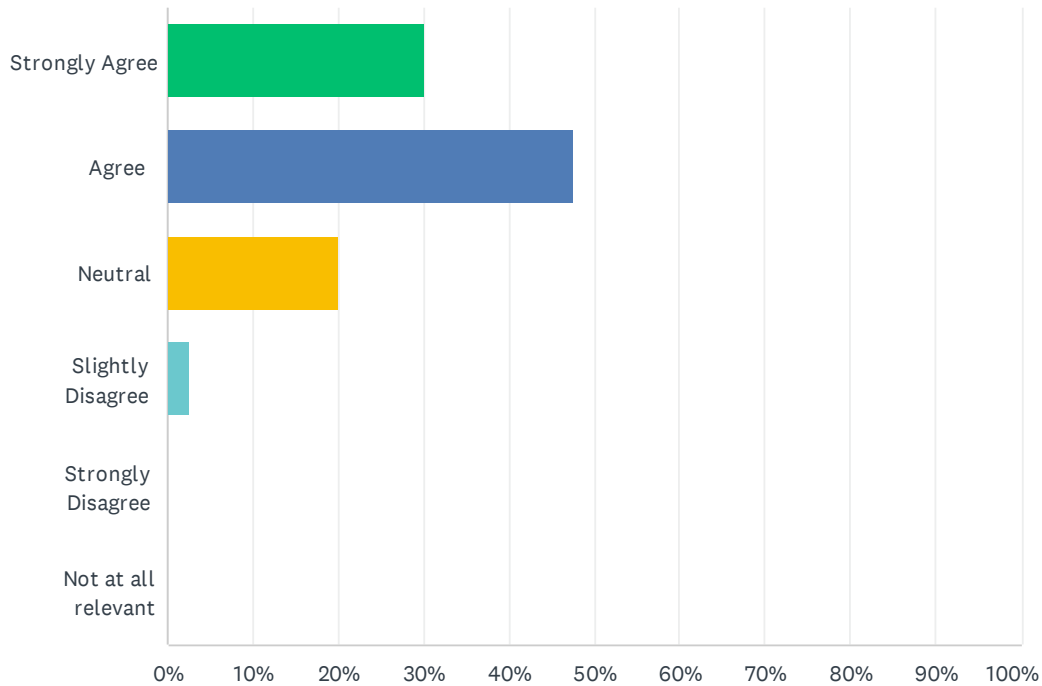

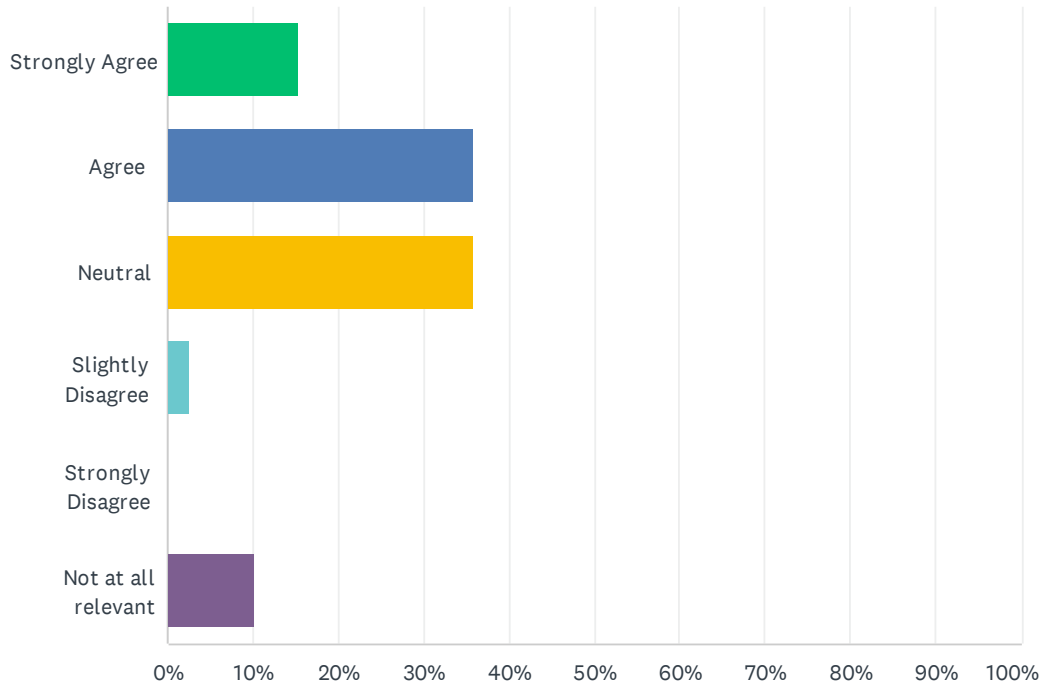

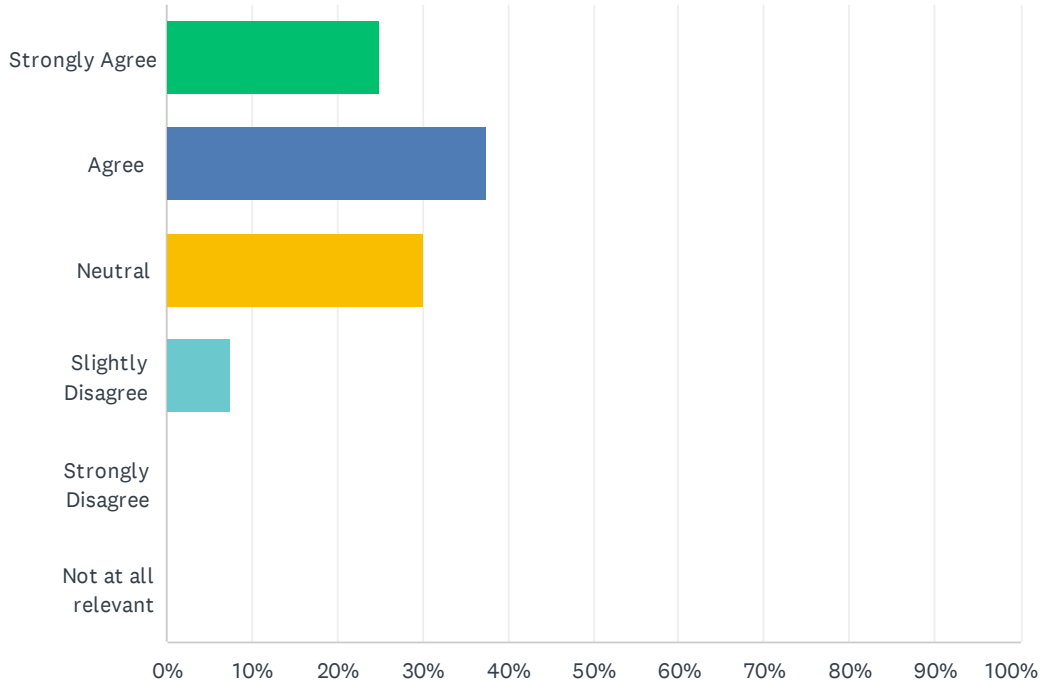

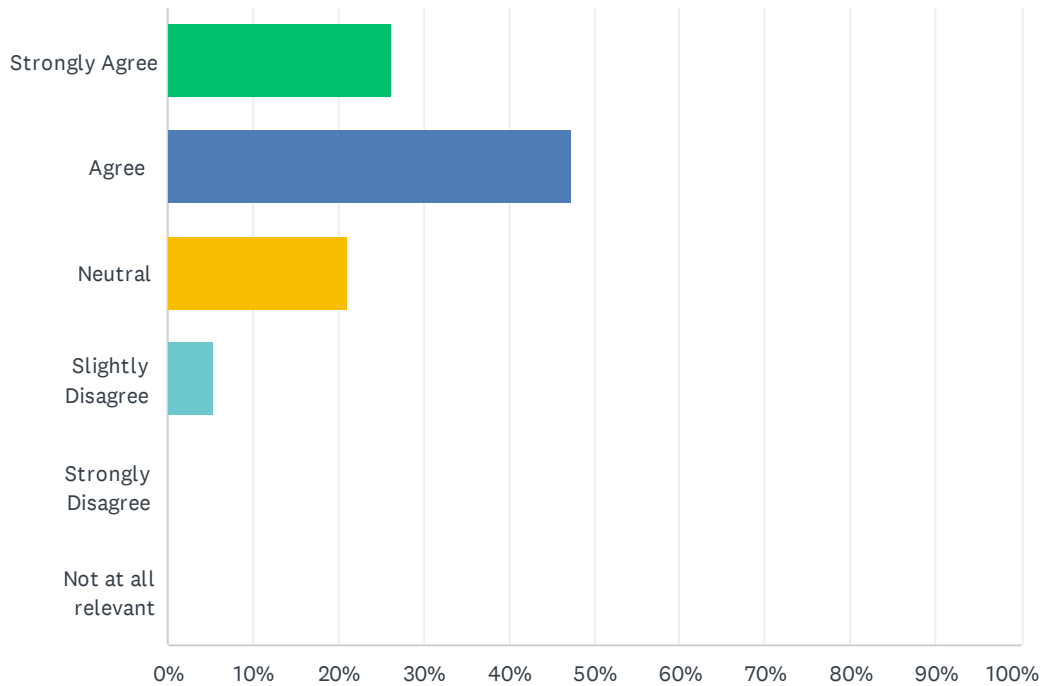

Q9 General Session 6: Inclusion Works: Centering Authentic Voices and Lived Experiences through a Vision and Mission - This general session was relevant to the work I do.

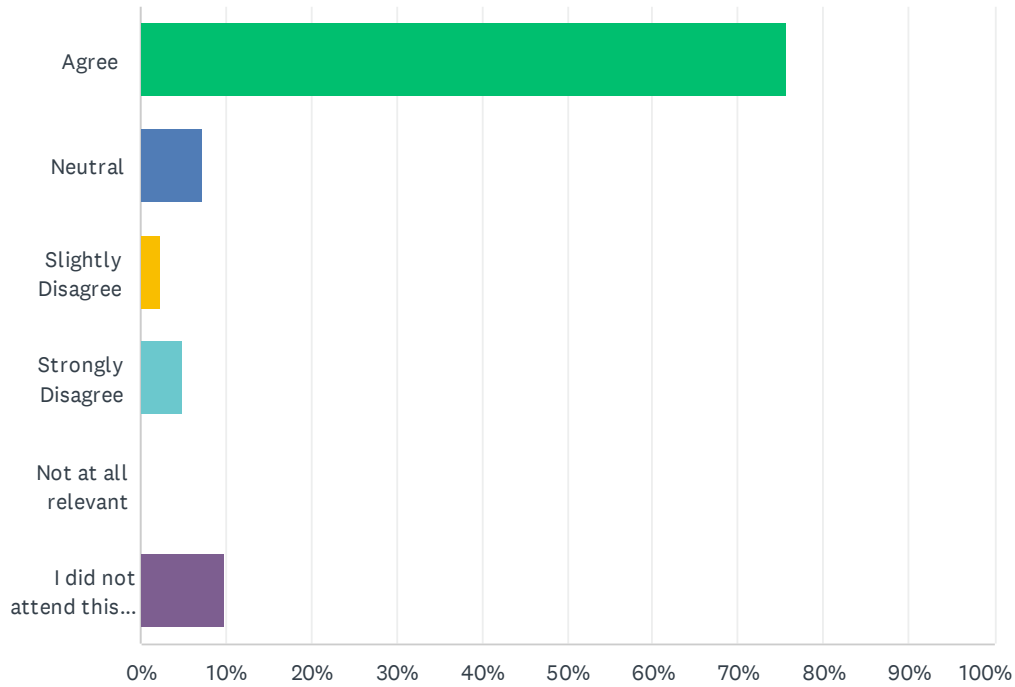

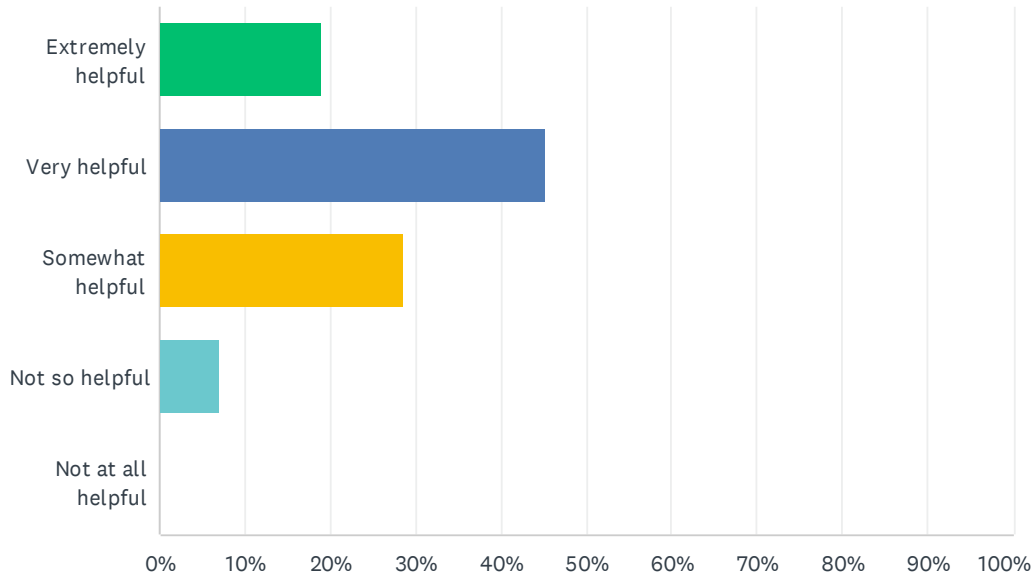

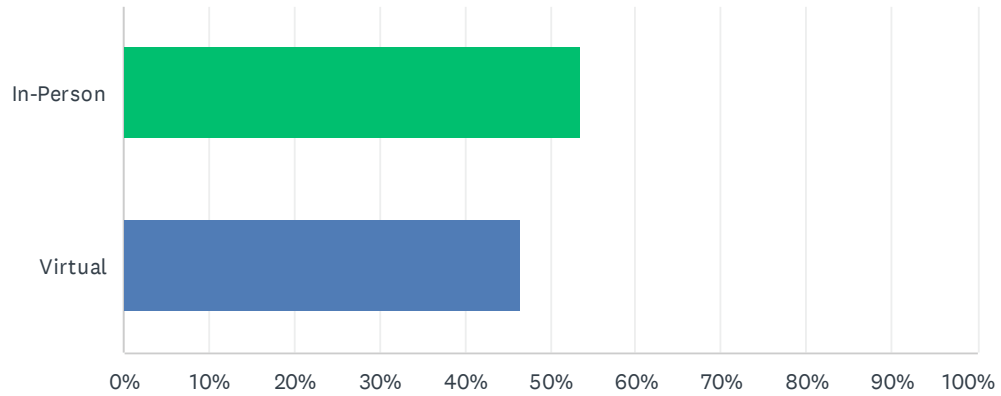

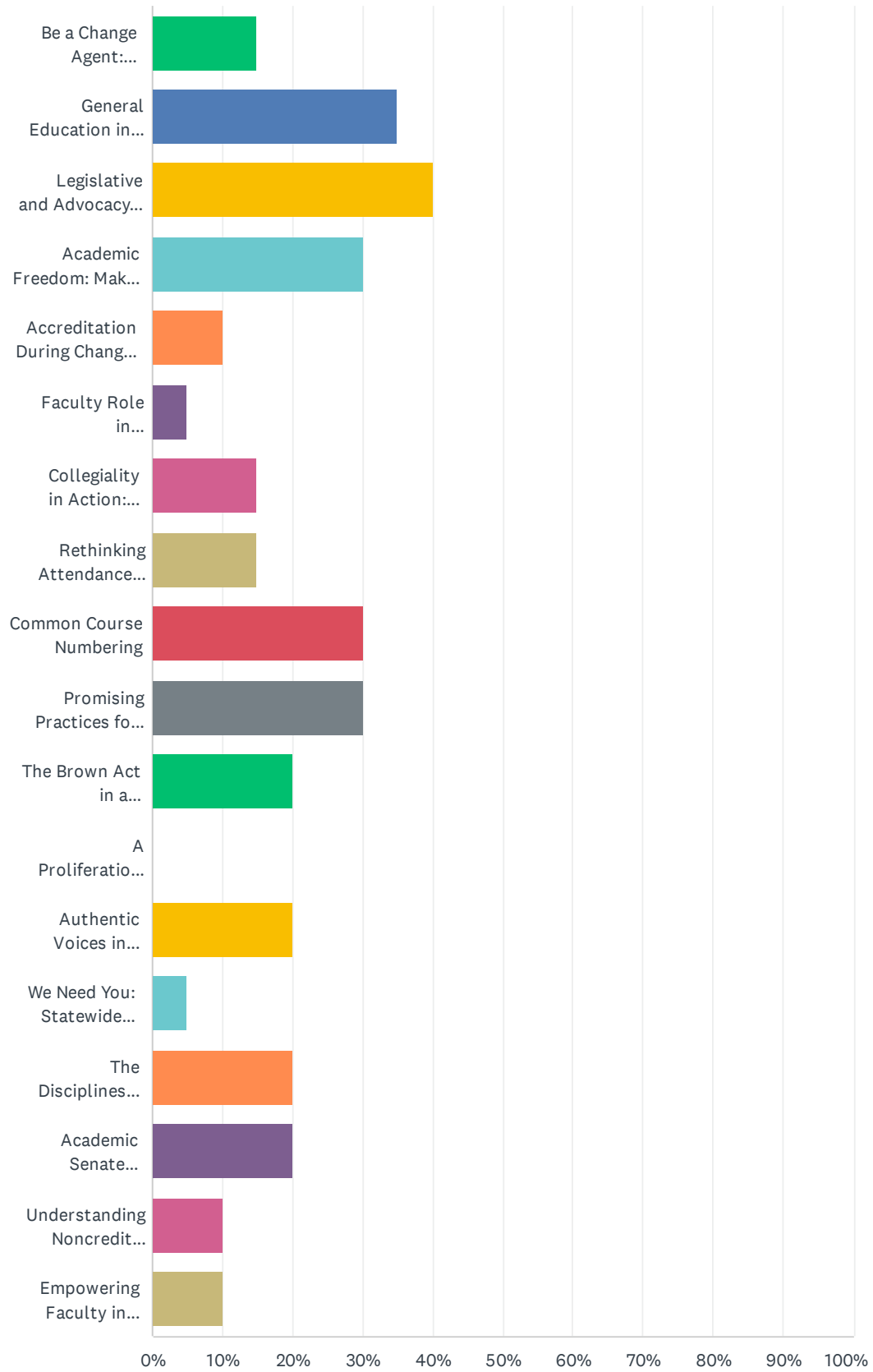

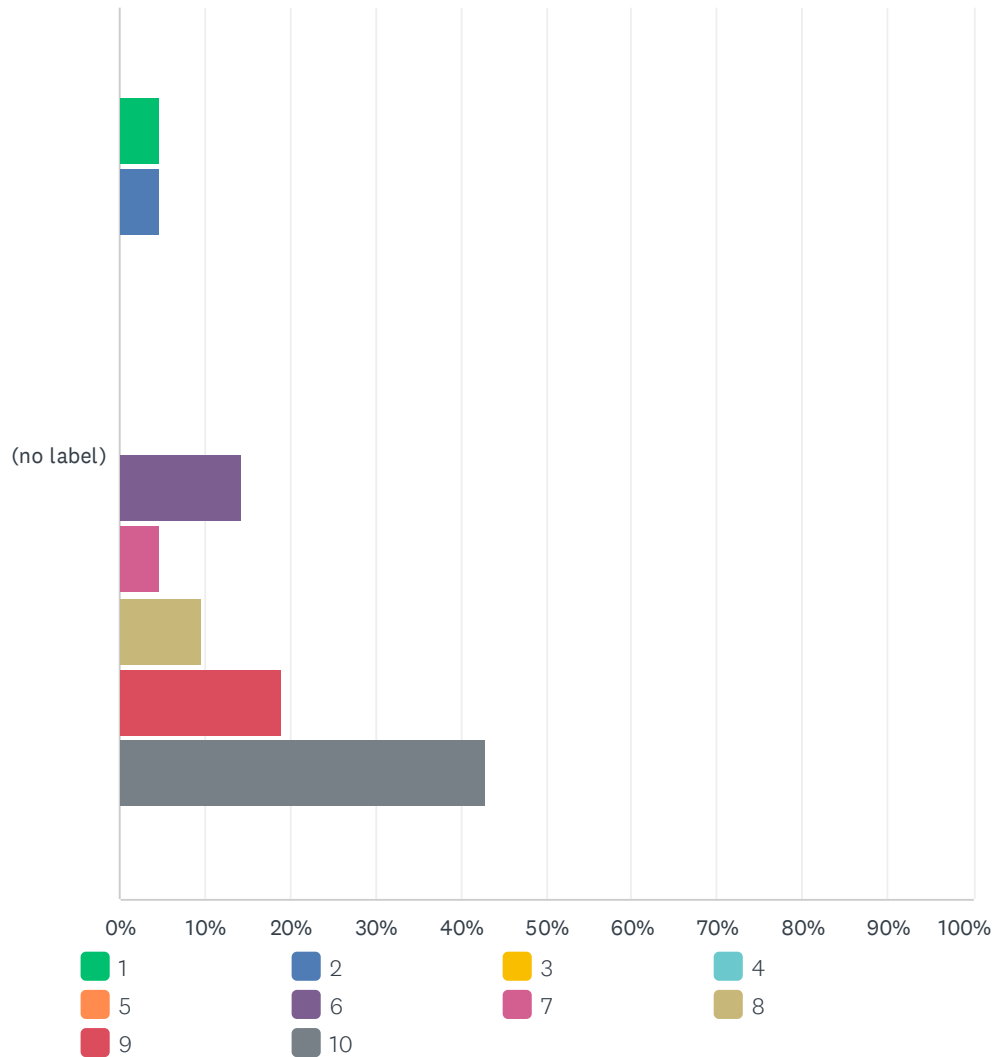

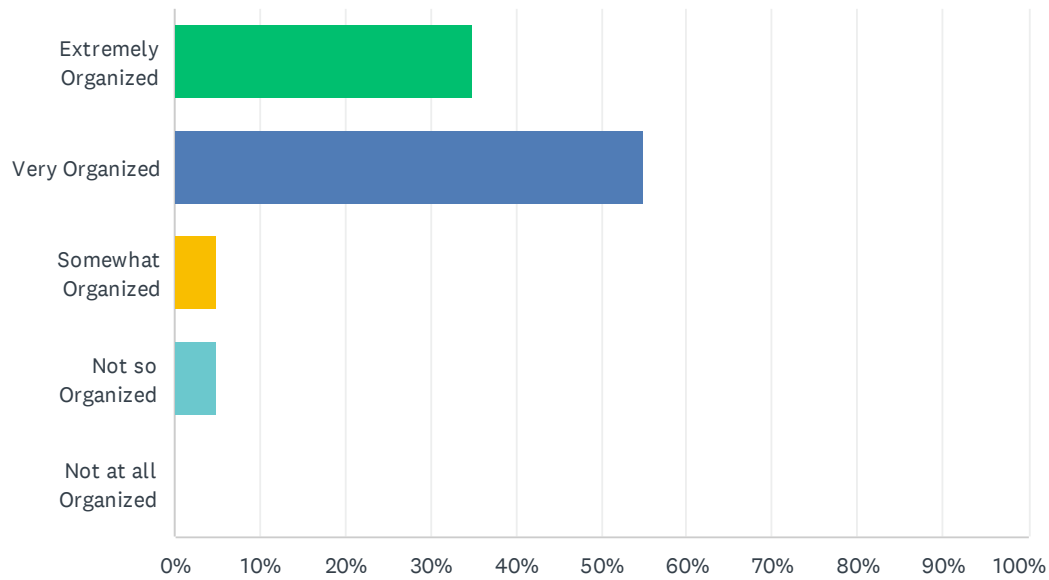

Q19 How organized was the event?

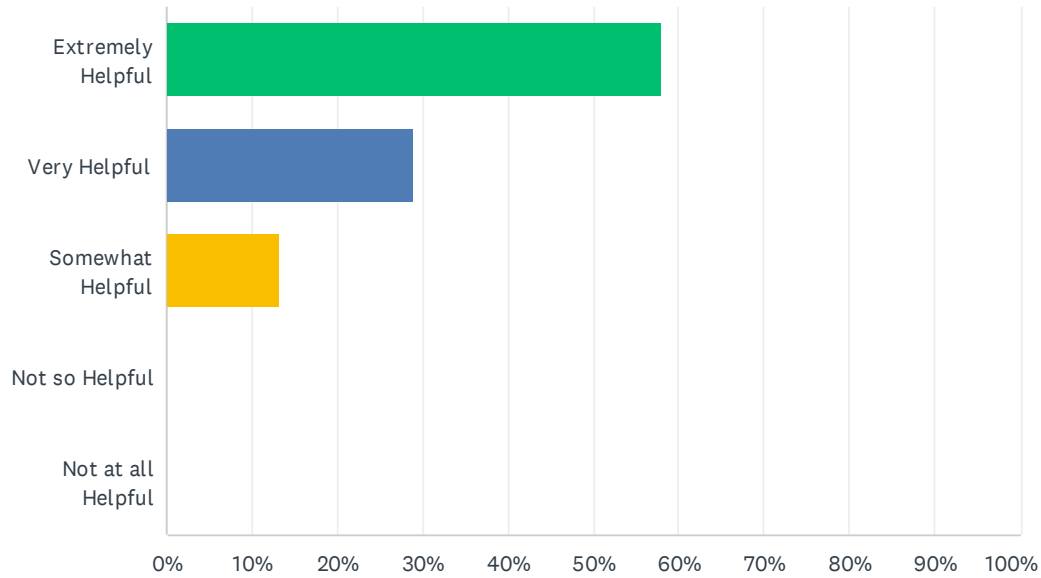

Q20 How helpful was the ASCCC staff?

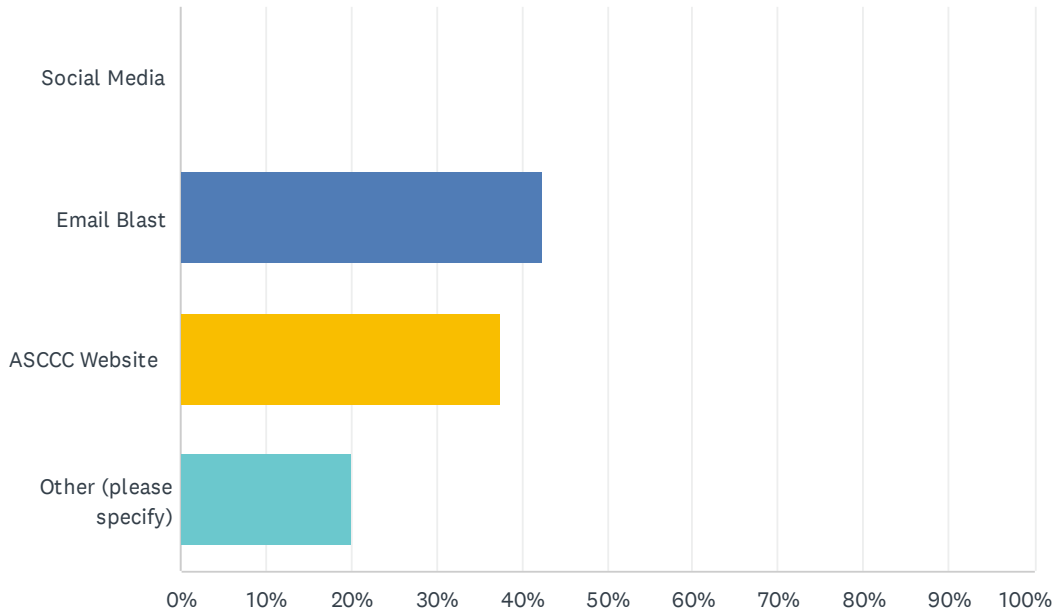

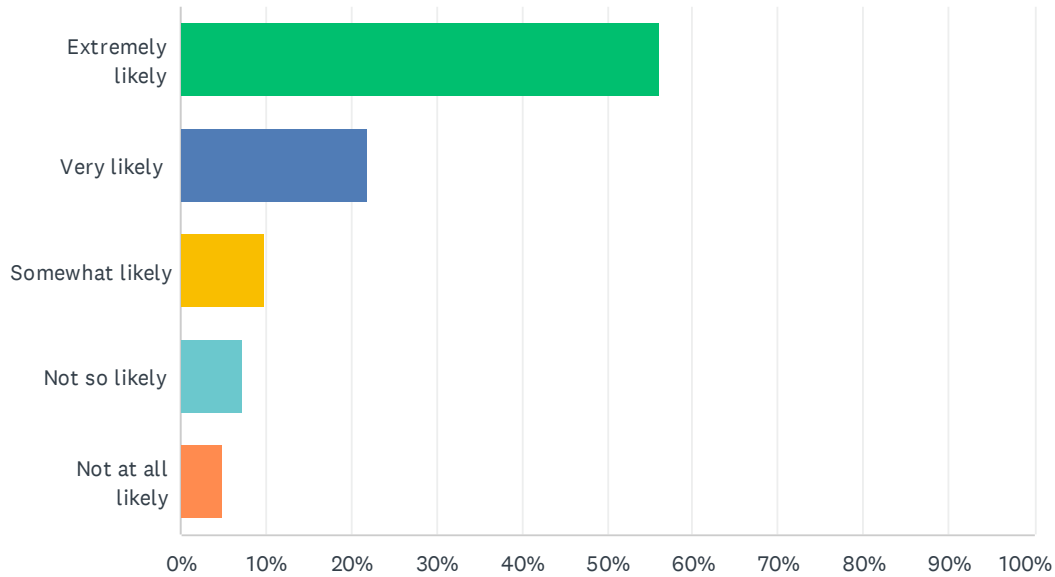

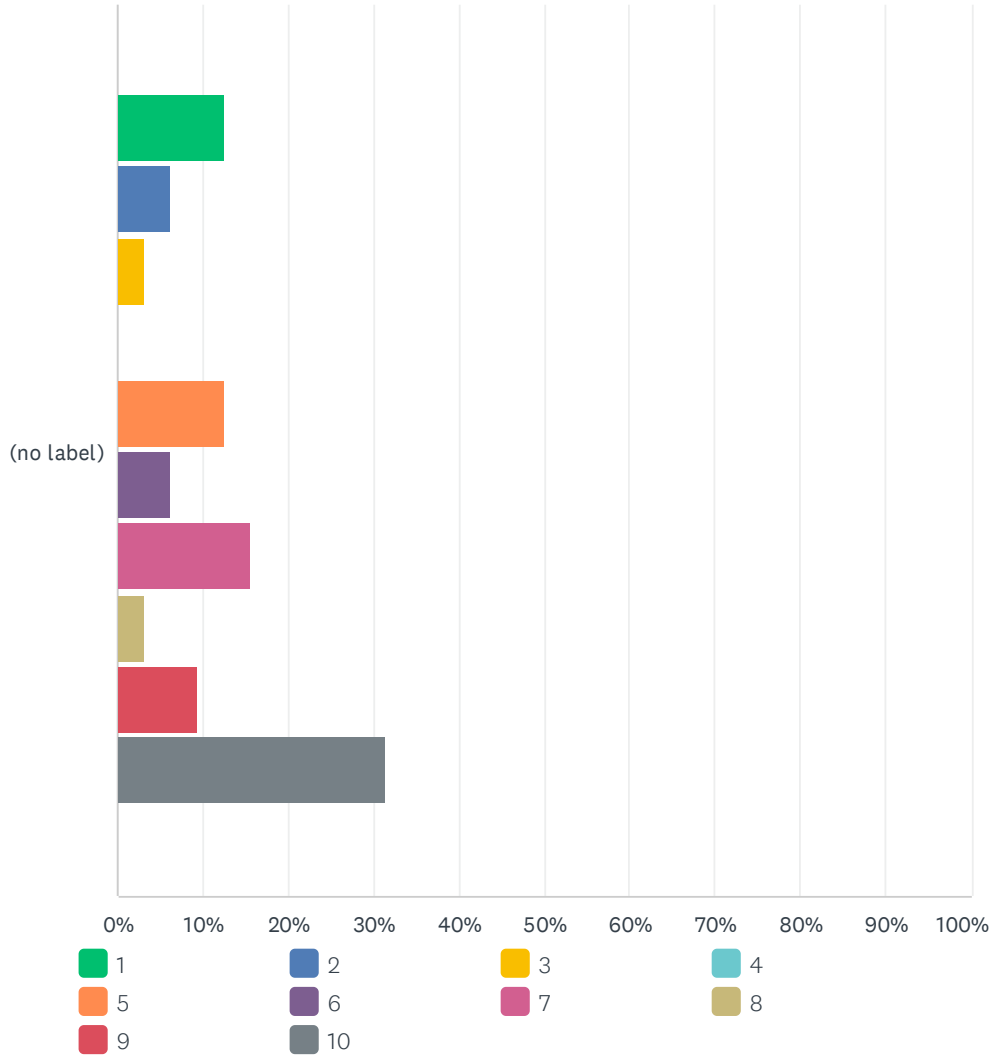

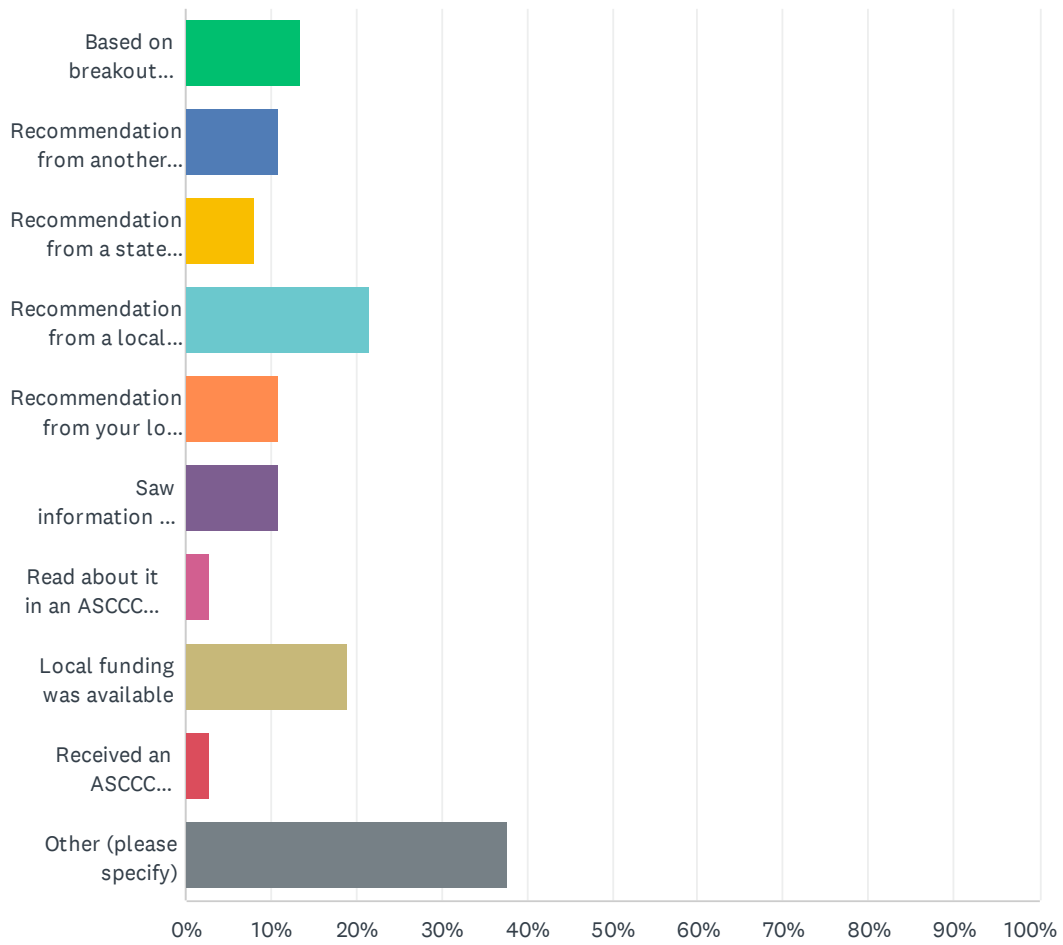

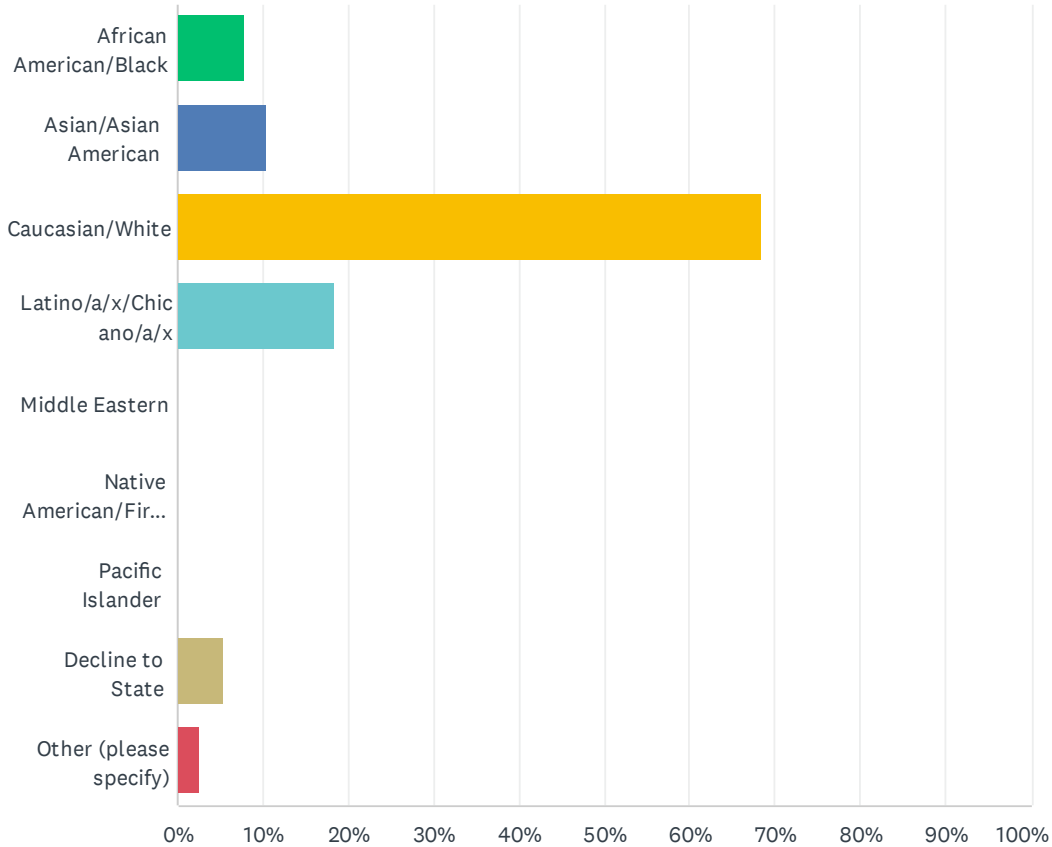

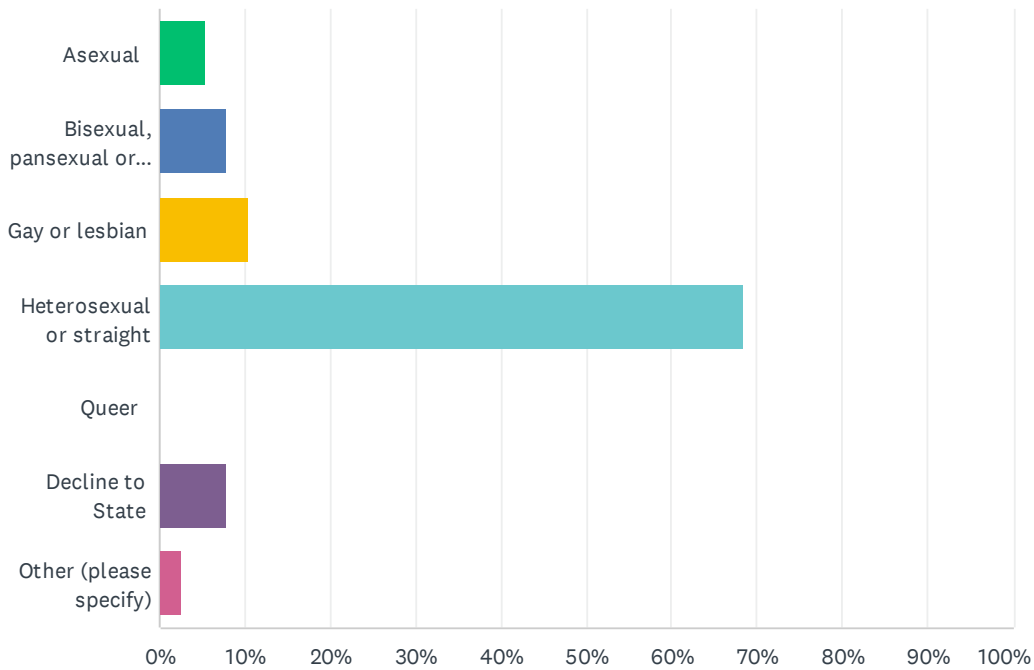

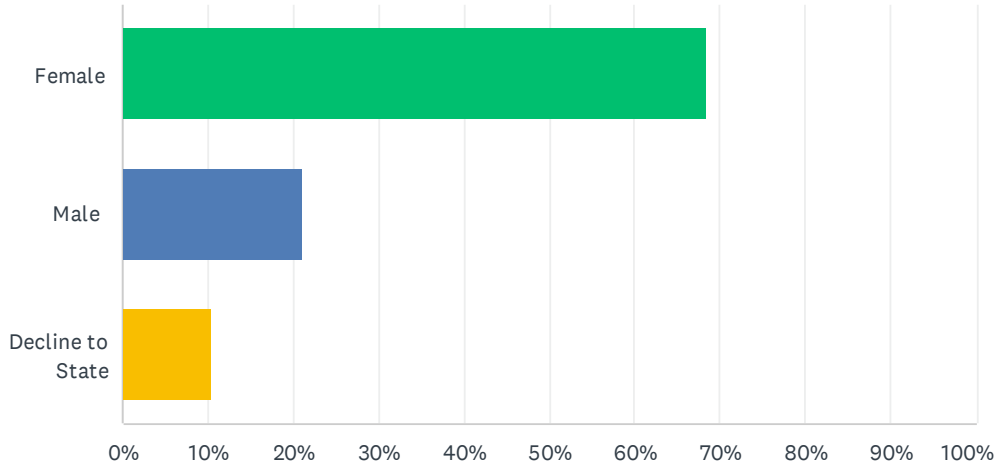

Q31 What sex were you assigned at birth or is on your original birth certificate?

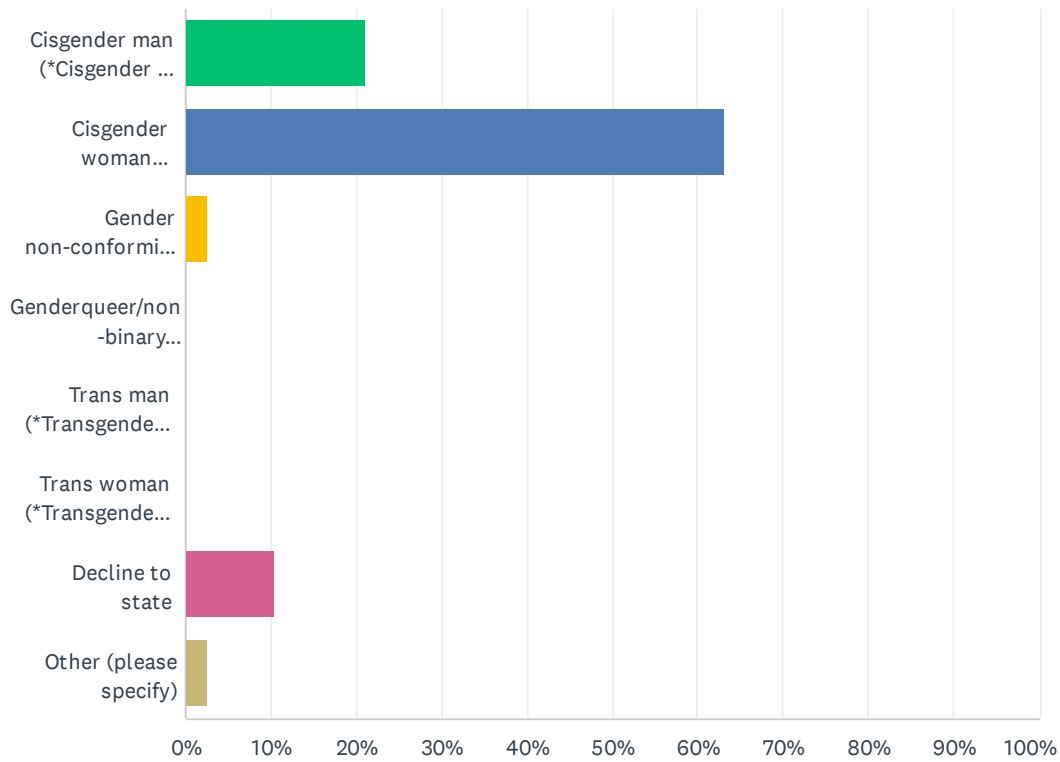
