THURSDAY, November 1, 2018

Registration/Delegate Sign-in: Registration and Delegate Sign-in began at 8:00 a.m.

Meet and Greet for First Time Attendees: Session participants attended an informal gathering for new attendees to network at 8:00 a.m.

Delegates Information Session and First Time Attendees: From 8:30 a.m. to 9:15 a.m. New delegates were provided with an overview of the aspects of the ASCCC plenary session and processes with a special focus on the resolution process, from where resolutions originate to specify style requirements. Participants discussed the requirements and obligations for delegates, the process by which resolutions are brought forth at plenary sessions, and the voting process used on Saturday.

FIRST GENERAL SESSION: From 9:30 a.m. to 10:30 a.m. Session participants attended the first general session. *Welcome and Call to Order:* President John Stanskas called the 51st Fall Plenary Session of the Academic Senate for California Community Colleges to order at 9:30 a.m. and welcomed delegates and guests.

Adoption of the Procedures: Vice President Dolores Davison presented the Academic Senate's Rules and Procedures and asked for their adoption. MSC: Adopt the Academic Senate's Rules and Procedures as presented.

Presentation: Student Centered Funding Formula

The higher education trailer bill to the state budget for 2018-19 establishes the new Student Centered Funding Formula (SCFF). The formula calculates apportionments to community college districts generally using three allocations: (1) a base allocation that considers enrollment, (2) a supplemental allocation that considers the number of low-income students enrolled, and (3) a student success allocation that considers student outcomes, with "premiums" for outcomes of low-income students. The Chancellor's Office has established an implementation team to do the following: (1) communicate how the implementation of the SCFF advances the Vision for Success under the Guided Pathways framework, (2) apportion funds consistent with the statutes related to SCFF, (3) support community colleges in implementing these policies by providing professional development and technical assistance, (4) align system policies, practices, and systems with these changes, and (5) maintain stability in the policy environment by making decisions transparently and with advice from interested parties. The Chancellor's Office provided updates on the implementation of these policies.

THIRD GENERAL SESSION: From 8:15 a.m. to 9:15 a.m. Session participants attended a third general session.

Resolution Presentation: President John Stanskas recognized Randy Beach, past member of the Executive Committee for Academic Senate for California Community Colleges and read the following resolution:

Keynote Presentation: AB 705 - Getting Ready for Fall 2019 - Laura Hope Executive Vice-Chancellor: By this time next year, all colleges will have implemented the first iteration of their new placement models, curricular innovations, and support structure in the areas of English and mathematics that align with the requirements of AB 705. Colleges will also be well on their way to full implementation for English as a Second Language. Does your college still have questions about what is and isn't permissible beginning next fall? In this session, participants joined together to learn about the framework for AB705 implementation, what options are available to colleges, and to take advantage of an opportunity to ask questions.

Foundation Address: Foundation President Cheryl Aschenbach provided attendees with an update on the Academic Senate Foundation

Presentation: Faculty Diversification – The Role of the Academic Senate and Senate Presidents: The ASCCC has a long-standing resolution stating that we should take a leadership role in promoting the diversification of the faculty at colleges. The statewide data clearly shows that the workforce employed by the CCC does not reflect the racial and ethnic composition of the state of California. This is also true when examining district service areas and district employees. What does it mean to take a leadership role in the diversification of faculty? How can we encourage our colleges to examine and address the structures and processes that may unconsciously limit our ability to attract and retain individuals that reflect the students and communities we serve? This general session was designed to address these issues and provide a framework for senate leadership and reflection in the diversification of our ranks.

FIFTH GENERAL SESSION: From 2:30 p.m. to 4:00 p.m. Session participants attended a fifth general session.

Presentation: —CTE Minimum Qualifications: Thinking Differently about Equivalency: The Chancellor's Office CTE Minimum Qualifications Workgroup has been working to address Strong WorkForce recommendation #13, which includes looking at equivalency to increase the pool of qualified CTE Instructors. Session participants were updated about the group's work developing examples of equivalency to the General Education requirements. The examples will be available for use by equivalency and hiring committees at colleges in an effort to help expand hiring pools to include potential instructors who do not have an Associate's degree. Attendees were provided the opportunity to share ideas and feedback in this interactive session to shape the ways in which we consider equivalency to the General Education areas of Associate' degree.
