C-ID Handbook

During the 2021-22 year C-ID began work on the C-ID handbook detailing C-ID processes and policies in one comprehensive document. Minor revisions and edits are being done and ICW/C-ID Advisory will finalize the document this fall.



TMC Modification, Discontinuation, and/or Consolidation Process

At an April 21, 2021 convening of the C-ID Advisory Committee and Intersegmental Curriculum Workgroup (ICW), it was determined that a workgroup consisting of ICW members would develop a draft process for discontinuing a transfer model curriculum (TMC) and for modification of a TMC such that elements of one TMC were removed from one and moved to another.

In Spring 2022 ICW finalized a process for modification of a TMC, and C-ID is working with the CCCCO to develop forms to help streamline the process.

Transfer Alignment Project

Overall Goal:

- 1. Align Transfer Model Curriculum (TMC) with University of California Transfer Pathways (UCTP), where feasible, i.e., only non-substantive changes to the TMCs would be needed
- 2. For those TMCs that need more changes, convene discipline faculty from all three systems, every attempt is made to align the pathways with two possible outcomes:
 - a. Pathways aligned with substantive changes to TMC and/or UCTP (currently, only TMCs have been considered for changes).
 - b. If the pathways cannot be aligned, then clear documentation on the rationale and benefits of separate pathways to students and public is communicated broadly.



Transfer Alignment Project

A UCTP tab is available on the C-ID website containing updates on the progress for each discipline with a UC Transfer Pathway.

Disciplines Aligned:

• The Sociology TMC is now aligned with the UC Transfer Pathway.

Disciplines Exploring Potential Alignment:

• Anthropology, English, History

• Biology, Business, Economics, Mathematics, Philosophy

Ethnic Studies TMC Development

Background:

C-ID organized and held three Discipline Input Group (DIG) meetings in Spring of 2021 to explore the possibility of developing a TMC for Ethnic Studies. Working with the Ethnic Studies Faculty Council, drafts were developed and sent to the field for feedback.

Fall 2022:

An FDRG consisting of faculty from both CCC, and CSU continues work to complete draft TMC and descriptors for statewide vetting. Additionally, C-ID is assisting the work of the CCCCO to finalize Ethnic Studies Core Competencies.



AO Subgroup

- C-ID Articulation Officer Subgroup
 - 3 CCC and 3 CSU AOs.
 - Meet with FDRGs during their 5-year review (and when developing TMCs).
 - Ideas for consideration this year:
 - Explore Women's /Gender Studies, as well as Data Science, as potential disciplines for C-ID development.
 - Course Modality
 - To the extent that it's possible: Involve AOs in AB 928 and AB 1111 implementation discussions.
 - Fund an AO who can research lower-division major requirements and present this information to FDRGs when they do their 5-year reviews.
 - Support the Transfer Alignment Project.



C-ID Faculty Participation & Recruitment

C-ID continues to experience challenges in recruiting and appointing CSU faculty to participate as Faculty Discipline Review Group (FDRG) and Course Outline of Record Evaluators (COREs).

FDRGs unable to continue the 5-year review due to lack of faculty appointments:

Administration of Justice • Elementary Teacher Education • English • Geology • History • Hospitality Management • Philosophy • Spanish •

Disciplines in need of CSU faculty COREs:

Accounting • Administration of Justice • Art History • Biology • Child Development • Early Childhood Education • Economics • Environmental Science • Film, Television & Electronic Media • Geology • Global Studies • Graphic Design • History • Journalism • Kinesiology •Law, Public Policy, and Society • Physics • Spanish



C-ID Faculty Participation Eligibility

- Efforts in Fall 2022 to determine FDRG and CORE engagement
 - Contact non-responsive faculty.
 - Work with new CSU Chancellor's Office representative to recruit CSU faculty.
- Future considerations:
 - FDRG turnover also to help improve diversity, equity, and inclusion.
 - Process to periodically confirm eligibility of faculty to serve as a FDRG member and/or CORE.



C-ID Website

Weekly meetings are held with the CCC Technology Center to review system development, discuss user needs, and ensure new areas of the site function as intended.

- 2022-2023 development will focus on:
 - FDRG member workflow
 - Upgrading the notifications and alert system.
 - Upgrades to the user dashboard.
 - Upgrades to the AO, CORE, and Site Administrator pages.
 - Complete work on an appeals process.
 - Website bugs.
